Dear Chairman Cole and Ranking Member DeLauro:

I am requesting funding for San Juan Phase 2 Infrastructure Project in Fiscal Year 2026.

The entity to receive funding for this project is City of Citrus Heights, located at San Juan Avenue, Citrus Heights, CA 95610.

The funding would be used for supporting engineering design, right-of-way acquisition, environmental approvals, and construction activities for Phase 2 of the San Juan Avenue Infrastructure Project, a 3,500-foot mixed-use corridor that serves freight, transit, bicycles, pedestrians, and personal vehicles.

The project is an appropriate use of taxpayer funds because Current conditions lack ADA compliance and have critical gaps in pedestrian infrastructure. This funding would build on Phase 1—funded through multiple SACOG grants and nearing full implementation—to enhance safety, mobility, and economic activity by modernizing a key transportation route in the region.

The project has a federal nexus because the funding provided is consistent with purposes authorized in 42 U.S.C.5305(a)(1), 5305(a)(2), 5305(a)(4), and/or 5305(a)(5).
